Objectives and Mission

Culture Unlimited Foundation promotes intercultural dialogue and social cohesion through music and cultural projects. The Culture Unlimited Festival focuses on new or rarely heard music — especially from the Eastern world — presented alongside contemporary Western repertoires. Local community participation is central to the programme, which spans contemporary classical, jazz, pop, electronic, and Eastern folk traditions.

Activity Report 2020

In 2020, no public festival or cultural activities were organised. Instead, the foundation focused on preparing the programme, partnerships, and funding for the 2021 edition of the Culture Unlimited Festival. The year was dedicated to strengthening organisational capacity and securing resources to ensure the successful relaunch of activities in 2021. It was COVID-19

- Organise the Culture Unlimited Festival annually in multiple Dutch cities (November–December)
- Develop educational and community programmes that engage diverse audiences
- Create new collaborations between Dutch and international musicians
- Build long-term partnerships with cultural organisations and venues
- Funding through subsidies, cultural funds, sponsorships, donations, and ticket sales
- Expenditure focused on artist fees, production, technical support, communication, and outreach

Organisation & Remuneration Policy

The foundation is governed by an unpaid, volunteer board. Project staff and freelancers are contracted per project. Artists and professionals are remunerated according to sector standards and fair fee guidelines.
